RULES OF Dr Vidya Sagar Oration Award

Dr. Vidya Sagar Oration Award has been instituted in the memory of late Dr. Vidya Sagar a senior fellow of the society. This oration will be delivered at each Annual Conference of the Punjab & Chandigarh Psychiatric Society.

RULE:

The process for orations award will start sufficient in advance before every Annual Conference of the society.

Any Life Fellow of the society can propose the name of any other Life Fellow of the Society for the oration award. The proposal including 3 copies of the bio-data of the nominee must be submitted to the Secretary of Punjab & Chandigarh Branch of Indian Psychiatric Society by a date determined by the Executive Council of the Society. The proposal must be accompanied by a written consent of the nominee.

To be eligible for the award, the nomination shall be assessed on the following criteria.

- a. Contribution to the service, development and awareness of psychiatry in Punjab & Chandigarh. (30 marks)
- b. Contribution to the Indian Psychiatric Society (Punjab & Chandigarh Branch)

(30 marks)

- c. Contribution to teaching, training, practice or research in Psychiatry. (20 marks)
- d. Overall seniority in Psychiatry, recognition and standing amongst fellow psychiatrists in Punjab & Chandigarh. (20 marks)

A panel of 3 judges shall rate the nominations one of the judges will be the President of Punjab & Chandigarh psychiatric Society. The nomination securing the highest total marks (out of 100) shall win the award, subject to ratification by the executive council of the society. In case of a tie, the concerned nominations shall be re-assessed by another panel of judges. To win an award not less than 50% of the full marks must be obtained by a nominee.

The oration paper will become the property of the Punjab & Chandigarh Psychiatric Society and can be published with the written permission of the Society. The speaker will pass on the oration paper to the Secretary, Punjab & Chandigarh Psychiatric Society as soon after the Annual Conference as possible for the necessary approvals from the executive council.

The speaker can choose any topic for the oration. He shall intimate the title of the oration to the President of the Society at least one month prior to the conference.

The Speaker will be paid a lump-sum for the oration. He will also be awarded a suitable scroll. No person shall win the award more than once.

Function for filling the Nomination Form:

- 1. You are requested to fill the Proforma (preferably typed) and three copies of the same be submitted to the Secretary of the Punjab and Chandigarh State Branch of Indian Psychiatric Society. You can attach extra sheets of paper to fill in further details.
- 2. A written consent of the Nominee is must to process the nomination.
- 3. The rules for the award of oration are being attached along with for your perusal. In case you need any clarification, you can get in touch with the State Secretary or the Award Committee.
- 4. It shall be clearly understood on your part that the Oration Paper becomes the Property of the State Branch of Indian Psychiatry Society.
- 5. Any dispute shall be addressed by the Awards Committee and the Executive Council of the Punjab and Chandigarh State Branch of Indian Psychiatric Society.
- 6. The decision of the above-mentioned Executive Council shall be final and binding.
